Dear friends,

The financial and economic crisis shows that the European Union is not capable of acting swiftly and effectively enough. The treaty of Lisbon has not provided sufficient means for adequate common action in economic and financial policies and has not armed the European Union appropriately for the challenges of globalization. We have to change this urgently. The EU needs more effective means to fight the crisis and tackle its roots. This is why we are asking: How can we change the treaties to ensure that the Union is capable of acting? Which powers do we have to transfer to the Union in areas like fiscal, budget, economic and tax policy in order to guarantee a stable economic union based on the principle of solidarity?
