



Keeping European democracy alive

o use Jacques Delors' words, the Common Agricultural Policy (CAP) and its budget are part of Europeans' "marriage contract". Maintaining the EU's trade leadership

he Jacques Delors Institute deciphers the functioning and priorities of the EU's trade policy, which must allow it to retain its ranking as the leading trade power in the world and to further leverage the strategic potential of this policy in its other external action areas.

While Europeans strive to retain their trade position against the rise of China and new economic powers, the EU's trade policy is proving to be all the more important for Member States' competitiveness as, in the future, 90% of demand growth will come from outside the EU. In addition, the stalemate in multilateral negotiations is not curbing Europeans' ambition to achieve more effective regulation of globalisation.



ver the period from 1996 to 2016, the Jacques Delors Institute has published more than 900 publications, among which 150 Studies & Reports, more than 200 Policy Papers and Policy Briefs, almost 300 Tribunes, 170 Syntheses of events or publications on Europe, and around 20 books. These publications can be viewed in French and English on our website.

Over 500 internal and external authors (see page 72) have provided their contribution to the debates on the main European challenges analysed by the Jacques Delors Institute, such as the Economic and Monetary Union, the Energy Union, relations with the EU's neighbours, European democratic and institutional challenges, the Single Market, cohesion and solidarity, the Federation of Nation States, mobility or the EU's influence in the world.



he Jacques Delors Institute has been on the web since the first years of its creation but from 2011 its presence was stepped up and improved. In 2011, the Institute created a new website boasting three times more visitors on average per month (22,000).

In 2009 a Facebook account was opened and turned into a page in 2011. In the same year, a Twitter account was launched. Our Presidents

OUR FOUNDING PRESIDENT: NEWS AND THE JACQUES DELORS ARCHIVES

Parliament's Economic and Monetary Affairs Committee until 1981, upon which he became Minister of Finance and Economy in France. In 1985, he left Paris for Brussels and acted as President of the European Commission for three terms of office. These ten years brought a new impetus to the European integration process, with in particular the implementation of the Single Market, the strengthening of Social Europe and the European budget, and the clear drive to create a genuine European citizenship that combines national sensitivities. The European Council awarded him the title "Honorary Citizen of Europe" in June 2015.

At the end of his presidency of the European Commission, Jacques Delors decided to create a think tank in favour of European construction. He named it "Notre Europe" (Our Europe) to stress its citizen dimension. The guiding principle behind this European think tank, founded in France in October 1996, was to propose analyses and recommendations on European politics, the issues that resonated with the actions and mindset of its Founding President, and the contemporary challenges facing the European Union.

Convinced that the past must enlighten the future, Jacques Delors decided to open his personal archives to consultation in 2015. In order to improve visibility and to make it easier to access these archives from different countries, the Jacques Delors Institute entered into communication and dissemination partnerships (including in particular a scholarship for researchers and an award for students) with many European academic organisations. The Jacques Delors Archives can now be viewed in Belgium, France, Italy, Poland and Switzerland.

OUR 4 OTHER PRESIDENTS

Jacques Delors, of Notre Europe in 1996, wished to step down from his duties in 2005 and passed on Chief of Staff at the European Commission, Pascal Lamy. Pascal of Notre Europe from 2004 to 2005, between the end of his term as a European and his appointment as Director-General of the World Trade consecutive terms between 2005 and 2013. He is currently President Emeritus of the Jacques Delors Institute and member of its Board of Trustees.

European Commissioner for Justice and Home Affairs during the Prodi Commission, **António** Vitorino took over the presidency at this Parliament in 1980, he was appointed Minister for Parliamentary Affairs in the government of Mario Soares (1983-1985), then Deputy Portugal's Constitutional <u>Court (198</u>9-1994) before being elected MEP became Deputy Prime Minister and Defence Minister of Portugal. A lawyer by profession an associate at the law firm Cuatrecasas, Goncalves Pereira & Associados since Board of Trustees.

Enrico Letta, former and Dean of the Paris Affairs at Sciences Po (PSIA), took over from 2016. He was the Italian Minister for European Affairs, then Minister the governments of Massimo D'Alema and acting as a member of the opposition from 2001 to 2006, he rejoined the government in 2006 as Secretary to under Romano Prodi. Our governing bodies

OUR BOARD OF TRUSTEES AS OF 5TH OCTOBER 2016

ommaso Padoa-Schioppa wished to create our Board of Trustees in 2009, with a view to ensuring continuity in the Institute's functioning and development, in accordance with its corporate purpose and founding principles.

Our Board of Trustees is made up of personalities close to our Founding President Jacques Delors, in particular his daughter Martine Aubry, Pascal Lamy and Étienne Davignon who have played an active role in Notre Europe since its foundation in 1996. The President of the Jacques Delors Institute sits in an ex officio capacity on the Board of Trustees but is not a formal member. Members of the Board of Trustees cannot combine this position with that of member of the Board of Directors. The composition of the Board of Trustees has changed only slightly since its creation in 2010. In 2015, Gerard Cromme replaced Pedro Solbes and António Vitorino joined the Board of Trustees in 2016 upon stepping down from the presidency of the Institute's Board of Directors.

The Vice-President and Treasurer attends meetings of the Board of Trustees and is assisted by a secretariat comprising the Institute's Director and officer in charge of development.

OUR BOARD OF DIRECTORS AS OF 5TH OCTOBER 2016

ur Board of Directors is responsible for the management of the Jacques Delors Institute and the steering and impetus of its work. It is chaired by Enrico Letta, who represents the Institute in all legal and public matters and authorises its expenditure.

Some personalities brought together by Jacques Delors in 1996 are still members of the Board of Directors today: Jean-Louis Bourlanges, Laurent Cohen-Tanugi, Élisabeth Guigou, Eneko Landaburu, Riccardo Perissich and Christine Verger. Pascal Lamy, also a founding member, left the Board of Directors in 2005, but joined the Board of Trustees upon its creation in 2010.

The composition of the Board of Directors is renewed regularly, in particular following the 2004 enlargement. The number of members has increased from sixteen in 1996 to 26 in 2016 (see page 75). It is currently made up of twenty-six members of eleven different nationalities (Belgian, British, Czech, French, German, Hungarian, Italian, Polish, Portuguese, Spanish and Swedish).

As we celebrate our 20th anniversary, our thoughts go to the members of the Board of Directors who are no longer with us and to their contribution to the development of our work: Tommaso Padoa-Schioppa, Jean Durieux, François Lamoureux, Jean François-Poncet, Loyola de Palacio, Karel Van Miert, Christian Join-Lambert, Fernand Braun and Philippe de Schoutheete.

OUR SECRETARY-GENERALS AND DIRECTOR

Adviser in the private office of the President of the European Commission Jacques Delors, then Director of the Representation of the **European Commission** in France from 1994 to 1996, Christine Verger was the first Secretary-General of Notre Europe, which she was in charge of creating and directed between 1996 and 1999 under the presidency of Jacques Delors. She then became Secretary General of the Party of European Socialists at the European Parliament (1999-2004) and is currently Director of relations with national parliaments at the European Parliament.

Agricultural engineer and graduate of the Institut National d'Agronomie in Paris and official of the French Ministry for Agriculture, Jean Nestor was Secretary-General of Notre Europe from 1999. He was behind the rise of our think tank, under the presidency of Jacques Delors. Former Secretary-General of the Mouvement européen - France, he was also Vice-President of Notre Europe. He stepped down as Secretary-General in 2004 and is currently retired.

In charge of the team for "European and international affairs" in the cabinet of the Belgian Vice-Prime Minister (1999-2002), then an official in the **European Commission** Directorate-General for Education and Culture, Gaëtane Ricard-Nihoul became Secretary-General of Notre Europe in 2004. She worked under the successive presidencies of Jacques Delors, Pascal Lamy and Tommaso Padoa-Schioppa. During her tenure, she published many studies on institutional and democratic issues. She joined the **European Commission** Representation in France in 2011 where she is currently Deputy Head and Director of the political unit.

Yves Bertoncini was appointed Director of the Jacques Delors Institute in April 2011. He also works in secondment as an administrator of the European Commission. He was previously adviser to the Secretary-General of European Affairs in Paris (2010-2011) and officer in charge of research on Europe at the Centre d'analyse stratégique (2006-2009). He also worked at the French Ministry of Foreign Affairs on the organisation of the "National Dialogue for Europe" (1995-1997) and at the French embassy in Algiers (1992-1993). He was Head of international affairs at the Fédération Française des Sociétés d'Assurance (French insurance association) from 2002 to 2005. He holds teaching positions at the Corps des Mines in Paris and the College of Europe in Bruges.



OUR TEAM IN 2016

n 1st October 2016, the Jacques Delors Institute team, under the direction of Yves Bertoncini, comprised eleven permanent members. Throughout the year, it has enjoyed the regular assistance of three research assistants, six advisors and three associate research fellows, in addition to the invaluable input of its president, of Pascal Lamy and of Jacques Delors. Eight nationalities are represented in the team: American, Belgian, French, German, Irish, Italian, Portuguese and Spanish (see page 77).

Our office in Germany, the Jacques Delors Institut – Berlin, was founded in January 2014, on the basis of a partnership with the Hertie School of Governance. As of 1st October 2016, its Director, Henrik Enderlein, is supported by a team of six research fellows, three affiliate research fellows, a communications officer, an administrative officer and a deputy administrative officer.

The two teams in Paris and Berlin work together in close coordination on the basis of a shared work programme.

Our financing


he foundation of Notre Europe in 1996 was made possible thanks to a decision of the European Council and funding from the European Commission: these two institutions were in favour of Jacques Delors continuing to contribute with his teams to drafting analyses and recommendations on the functioning and future of the European Union.

Our financing sources have gradually diversified since then and are now based on multi-year public and private contributions from several EU Member States. Funding also comes from perproject contributions, in particular from calls for tenders. Since 2015, our financing is supplemented by contributions from citizens accepting to join our pool of donors.

We wish to take this opportunity in the celebration of our Institute's $20^{\rm th}$ anniversary to express our heartfelt thanks to all our major partners, partners and donors.

Our average annual budget has doubled since the Institute was founded (see Figure below) and now accounts for approximately €1.4 million.

OUR MAJOR PARTNERS

Our major partners provide multi-year support for our work, contributing sums exceeding €100,000 per year.

The European Commission is the Jacques Delors Institute's long-standing major partner, despite the steady decrease in its multi-year subsidy over the last twenty years. Its funding is allocated to the Institute as part of the call for tenders of the "Europe for Citizens" programme and remains the largest multi-year contribution we receive.

The French government joined the European Commission as our second major partner in 2008.

MACIF was also one of our major partners between 2010 and 2015 and remains our partner today. The same goes for the Compagnia di San Paolo between 2009 and 2014, and the Institute still receives perproject contributions from this partner.









OUR PARTNERS

Our partners provide multi-year support for our work, contributing amounts exceeding €50,000 per year. In 2016, the Jacques Delors Institute counted on the support of four of these partners: MACIF, Engie, the Calouste Gulbenkian Foundation and Solvay.



OUR EXPENDITURE

Our annual expenditure doubled between 1996 and 2016, reaching an average level of &1.4 million per year in the last few years.

This expenditure is fairly evenly divided between three areas of activity (see Figure below):

- Expenditure linked to our analytical and research activities, which comprises the remuneration of our research fellows and of the external authors who produce our publications under our guidance, and the expenses that we incur in organising research seminars:
- Expenditure linked to our dissemination, comprising the remuneration of our team members in charge of dissemination and of the communication, publication, printing and dissemination of our publications, expenses incurred in organising events for the dissemination of our research and translation costs, as well as costs incurred in funding travel, board and lodging;
- Expenditure linked to support activities and to our day-to-day running, chiefly comprising the remuneration of our administrative staff and operating costs, primarily the rent for our offices and depreciation.
